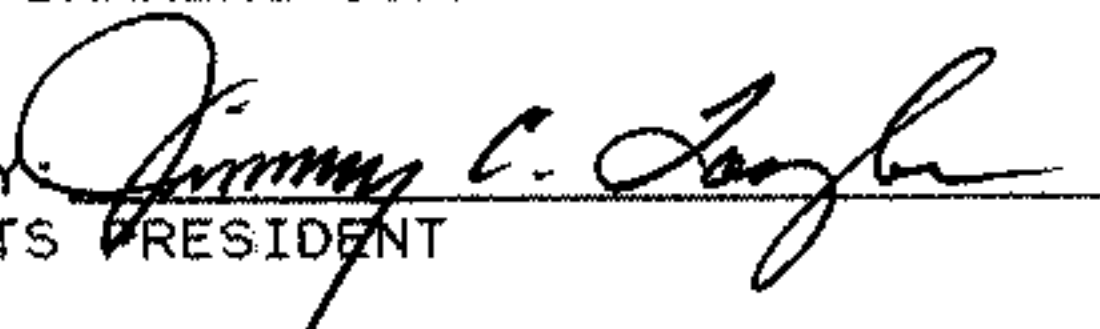
MORTGAGE RELEASE AND POWER OF ATTORNEY

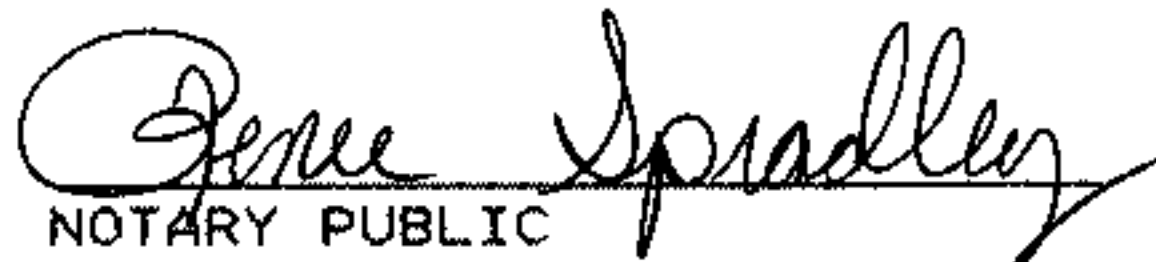
