AMENDMENT TO ADJUSTABLE-RATE LINE OF CREDIT MORTGAGE

This Amendment (the "Amendment") is made and entered into on February 18, 19 94, by and between Charles A. Hunt and wife, Judith P. Hunt (hereinafter called the "Mortgagor", whether one or more) and AmSouth Bank N.A., a national banking association (hereinafter called the "Mortgagee").

RECITALS

- A. Charles A. Hunt and wife, Judith P. Hunt

 (hereinafter called the "Borrower", whether one or more) has

NOW, THEREFORE, in consideration of the premises, and in further consideration of any advances made by the Mortgagee in excess of the original Credit Limit described in the Mortgage, the Mortgagor and the Mortgagee agree that the Mortgage is, effective as of the date of this Amendment, hereby amended as follows:

In addition to the other "Debt" described in the Mortgage, the Mortgage shall secure the payment of all advances heretofore or from time to time hereafter made by the Mortgagee to the Borrower under the Credit Agreement, or any extension or renewal thereof, up to a maximum principal amount at any one time outstanding not exceeding the Amended Credit Limit of Thirty Thousand And No/100 (\$\frac{30,000.00}{}).

Except as specifically amended hereby, the Mortgage shall remain in full force and effect in accordance with its terms.
