QUITCLAIM DEED

KNOW ALL MEN BY THESE PRESENTS that GTE Sprint Communications Corporation ("Grantor"), a Delaware corporation and successor in interest to Southern Pacific Communications Company ("SPCC") under a grant of easement dated July 31, 1981, ("Easement") between Kimberly-Clark Corporation ("Kimberly-Clark") and SPCC, does hereby remise, release and quitclaim to Kimberly-Clark ("Grantee"), all its right, title and interest in the real property which is the subject of such Easement and which is situated near the town of Maylene, County of Shelby, State of Alabama, described as follows:

A parcel of land containing six (6) acres, more or less, located in the Northwest 1/4 of the Northwest 1/4 of Section 29 and the Northeast 1/4 of the Northeast 1/4 of Section 30, all in Township 21 South, Range 3 West, Shelby County, Alabama, more particularly described as follows: Commence at the Southwest corner of said Section 29, thence in a Northerly direction, along the West line of said Section, a distance of 4,045.20 feet to the Point of Beginning; thence 90 degrees right, in an Easterly direction, a distance of 329.265 feet, thence 90 degrees left, in a Northerly direction, a distance of 511.23 feet, thence 90 degrees left, in a Westerly direction, a distance of 511.23 feet, thence 90 degree left, in a Southerly direction, a distance of 511.23 feet, thence 90 degrees left, in an Easterly direction, a distance of 181.965 feet to the Point of Beginning.

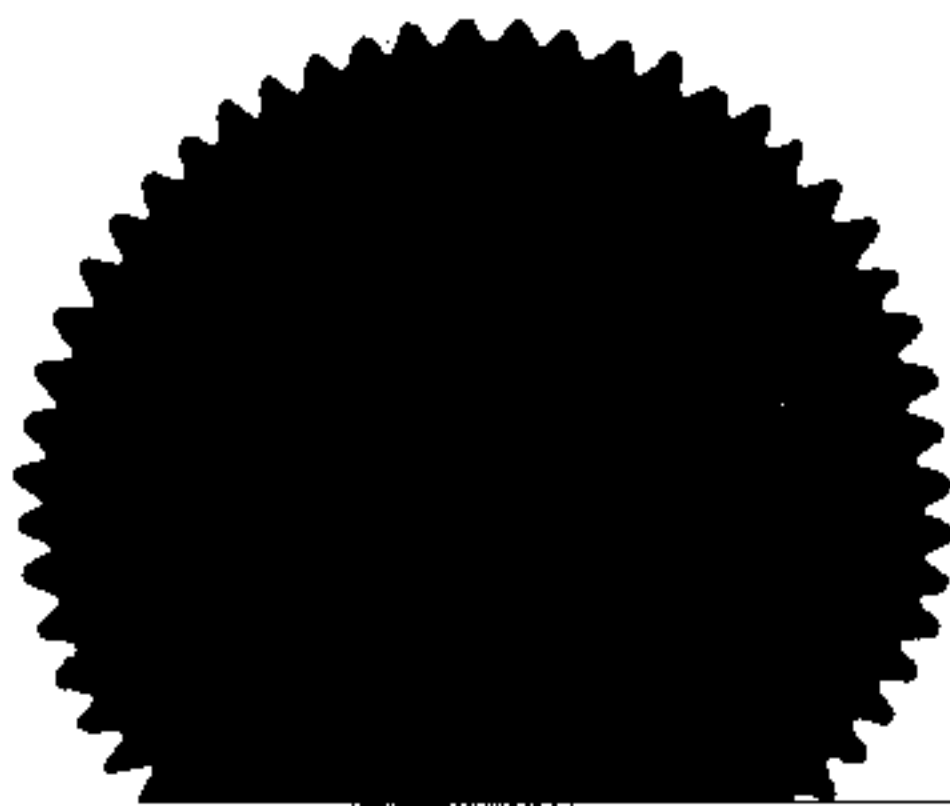
