
EXHIBIT "A"  
LEGAL DESCRIPTION

A lot in the Town of Columbiana, Alabama in the SW 1/4 of NW 1/4 of Section 25, Township 21 South, Range 1 West, more particularly described as follows: Begin at a point on the North margin of Mildred Street, 325 feet, East of the East line of Catherine Street, said point being the Southwest corner of the F. E. Leonard property and being marked by an iron pin; and from said point of beginning run in an Easterly direction along the North line of Mildred Street a distance of 80 feet to an iron pipe at the Southwest corner of the Conrad M. Fowler lot; thence in a Northerly direction along the Westerly line of the Conrad M. Fowler lot a distance of 178 feet to an iron pipe; thence in a Westerly direction a distance of 81 feet to the East line of the C. H. Fore lot at a point 171 feet distant, measured along the East line of the C. H. Fore lot from the North line of Mildred Street, which point is marked by an iron pipe; thence in a Southerly direction along the East line of the C. H. Fore lot a distance of 171 feet to the point of beginning.
