

MORTGAGE FORECLOSURE DEED

KNOW ALL PERSONS BY THESE PRESENTS: That Khris L. Robinson, and wife, Janet M. Robinson, did, on to-wit, May 27, 1991, execute a mortgage to First General Lending Corporation which is recorded in Mortgage Record Book 345, Page 259, et seq., in the Office of the Judge of Probate of Shelby County, Alabama; and which said mortgage, security, lien and the indebtedness secured thereby, was assigned to and acquired by Wachovia Mortgage Company by document recorded in Mortgage Book 345, Page 264, in the Office of the Probate Judge of Shelby County, Alabama; and
