Grantor, in consideration of Five Hundred dollars (\$500.00) paid by Grantee, does hereby grant to Grantee, her heirs and assigns, all that land lying in the NW 1/4 of the SW 1/4 of Section 24, Township 18 South, Range 1 East, Huntsville Principle Meridian, County of Shelby, State of Alabama, and bounded and described as follows: Commencing at the Southwest corner of the NW 1/4 of the SW 1/4 of Section 24, Township 18 South, Range 1 East, Shelby County, Alabama, run North along the west section line 273.42 feet to the Point of Beginning; thence continue North along said west Section line for 273.42 feet to a point; thence turn a left interior angle of 89°31'21" and run easterly 330.12 to a point; thence turn a left interior angle of 90°28'39" and run southerly and parallel to the west section line 273.42 feet to a point; thence turn a left interior angle of 89°31'21" and run westerly 330.12 feet to the Point of Beginning, making a closing left interior angle of 90°28'39" and containing 2.072 acres, more or less. Subject to any and all easements, rights-of-way, limitations and /or restrictions of probated record or applicable law, including but not limited to ingress and egress by way of an unimproved road which passes through the northeast portion of the property and utilities, if any, along this road, together with tenements, hereditaments, and appurtenances thereto belonging, and reversions, remainders, rents, issues, and profits, if any, thereof.

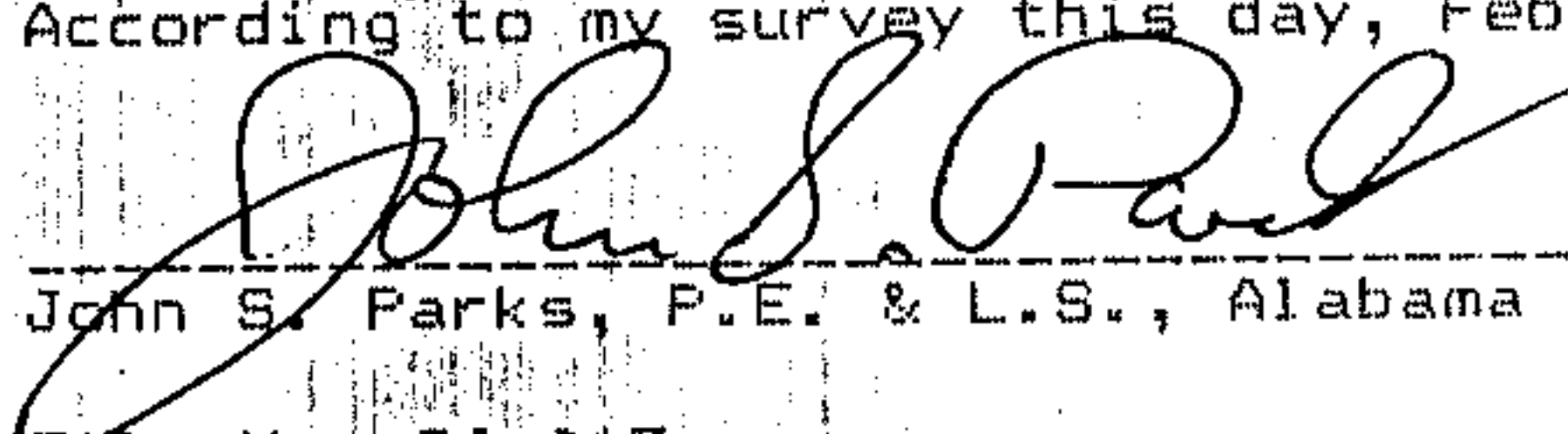

Subject to any and all easements, rights-of-way, limitations and/or restrictions of probated record or applicable law.
