Stevens, deceased, at the time of her death, specifically including, without limitation, the interest of said decedent in and to the real property described on Exhibit A attached hereto and made a part hereof.

TO HAVE AND TO HOLD the said real property, together with the rights, members, privileges, tenements, improvements, hereditaments, easements and appurtenances thereunto belonging or in anywise appertaining, to the said Carolyn Busby Moore and Sims Binion Busby, as tenants-in-common as aforesaid, and to their respective heirs and assigns, forever, subject, however, to all matters to which reference is hereinabove made.
