**WARRANTY DEED**

KNOW ALL MEN BY THESE PRESENTS: That in consideration of One Hundred Thirty-One Thousand Two Hundred Eighty and No/100 Dollars (\$131,280.00), to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, we, ORDNANCE TESTING, INC., a corporation and BROOKLINE FOREST, INC., a corporation (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto HOWARD W. LOVELESS, JR. (an undivided 1/2 interest) and ORDNANCE TESTING, INC., a corporation (an undivided 1/2 interest) (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

Lots 1, 2 and 3, according to the Map and Survey of River Oaks as recorded in Map Book 18, Page 70 in the Probate Office of Shelby County, Alabama.
