## EXHIBIT "A"

## Description of Mortgaged Property

Begin at the Southwest corner of the Southwest Quarter of the Northeast Quarter of said Section 27, thence run West along the North line of the Northeast Quarter of the Southwest Quarter of said Section 27 for a distance of 146.56 feet to a point; thence turn an angle to the left of 19 degrees, 58 minutes, 30 seconds and run in a Southwesterly direction for a distance of 50.55 feet to a point; thence turn an angle to the left of 18 degrees, 01 minutes, 30 seconds and run in a Southwesterly direction for a distance of 56.14 feet to a point; thence turn an angle to the right of 90 degrees, 00 minutes, 00 seconds and run in a Northwesterly direction for a distance of 150.00 feet to a point; thence turn an angle to the left of 90 degrees, 00 minutes, 00 seconds and run in a Southwesterly direction for a distance of 180.00 feet to a point; thence turn an angle to the right of 90 degrees, 00 minutes, 00 seconds and run in a Northwesterly direction for a distance of 183.98 feet to a point; thence turn an angle to the right of 91 degrees, 26 minutes, 47 seconds and run in a Northeasterly direction for a distance of 60.82 feet to a point; thence turn an angle to the right of 9 degrees, 53 minutes, 21 seconds and run in a Northeasterly direction for a distance of 635.80 feet to a point; thence turn an angle to the right of 116 degrees, 39 minutes, 20 seconds and run in a Southeasterly direction for a distance of 67.14 feet to a point; thence turn an angle to the left of 116 degrees, 39 minutes, 20 seconds and run in a Northeasterly direction for a distance of 227.42 feet to a point; thence turn an angle to the right of 99 degrees, 12 minutes, 41 seconds and run in a Southeasterly direction for a distance of 122.61 feet to a point; thence turn an angle to the right of 17 degrees, 26 minutes, 39 seconds and run in a Southeasterly direction for a distance of 50.00 feet to a point; thence turn an angle to the left of 91 degrees, 03 minutes, 39 seconds and run in a Southeasterly direction for a distance of 270.05 feet to a point; thence turn an angle to the left of 10 degrees, 53 minutes, 44 seconds and run in a Northeasterly direction for a distance of 86.88 feet to a point; thence turn an angle to the right of 14 degrees, 35 minutes, 06 seconds and run in a Southeasterly direction for a distance of 261.83 feet to a point on the Northwest line of Independence Drive of Autumn Ridge as recorded in Map Book 12, on Page 5, in the Office of the Judge of Probate, Shelby County, Alabama; thence turn an angle to the right of 108 degrees, 27 minutes, 21 seconds and run in a Southwesterly direction along the Northwest line of said Independence Drive for a distance of 88.00 feet to a point on a curve to the left having a central angle of 8 degrees, 55 minutes, 48 seconds and a radius of 1,410.66 feet; thence run in a Southwesterly direction along the arc of said curve and also along the Northwest line of said Independence Drive for a distance of 219.86 feet to a point; thence run in a Southwesterly direction along the Northwest line of said Independence Drive tangent to last stated curve for a distance of 8.61 feet to a point on the South line of the Southwest Quarter of the Northeast Quarter of said Section 27 and also being on the North line of said Autumn Ridge; thence turn an angle to the right of 77 degrees, 50 minutes, 44 seconds and run in a Westerly direction along the South line of said Quarter-Quarter Section and also along the North line of said Autumn Ridge for a distance of 791.60 feet to the Inst # 1994-18267 point of beginning.
