FINAL JUDGMENT OF DIVORCE

THIS CAUSE, coming to be heard, was submitted for final judgment upon Default entered by the Register of this Court based upon Defendant's failure to answer Plaintiff's bill of complaint. Upon consideration thereof, and the ore tenus testimony of the Plaintiff in open Court, it is,

ORDERED and ADJUDGED by the Court as follows:

FIRST: That the bonds of matrimony heretofore existing between the parties are dissolved and the said DONNA P. GLASGOW and said HENRY M. GLASGOW are divorced from each other.

SECOND: That neither party shall marry again except to each other until sixty (60) days after the date of this Judgment of Divorce, and if an appeal is taken (which must be instituted within forty-two (42) days from this Judgment, or from the date that a post-trial motion is denied), then neither party shall again marry except to each other during pendency of the appeal.

THIRD: The Plaintiff is awarded all personal property, including but not limited to, furnishings, appliances and other personal property which she has in her name and in her possession and the Defendant is divested of any interest.

FOURTH: The Defendant shall pay to the Plaintiff as alimony in gross the sum of Three Thousand Dollars (\$3,000.00). Said amount is due thirty (30) days from the date of this decree.

FIFTH: That the Plaintiff is awarded all right, title and interest in and to the 1986 Chevrolet Camaro automobile and the Defendant is divested of any interest.
