
SUBORDINATION AGREEMENT

THIS SUBORDINATION AGREEMENT (the "Agreement") is made and entered into by and between **HIGHLAND BANK** (the "Lender") and **ALEXANDER CONSTRUCTION COMPANY** and **MIKE ALEXANDER** (collectively the "Contractor") as of the 14th day of June, 1994.

W I T N E S S E T H:

WHEREAS, the Lender has agreed to make a loan (the "Loan") to **Larry W. Vines and Dottie O. Vines** (collectively the "Borrower") on the condition that, among other things, Contractor subordinate all liens of any nature whatsoever heretofore or hereafter arising or to which the Contractor may be entitled, including, without limitation, mechanics and materialsman's liens (collectively the "Liens") to all liens and rights of the Lender under all agreements and documents (the "Loan Documents") relating to the Loan, including, without limitation, that certain Future Advance Mortgage and Security Agreement (the "Mortgage") granted or to be granted by Borrower in favor of the Lender; and

WHEREAS, the Contractor has agreed to subordinate the Liens and all of its right, title, and interest in and to the property described in EXHIBIT A to the liens and rights of the Lender.

NOW, THEREFORE, in consideration of the premises, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and to induce the Lender to make the Loan, the Contractor represents, warrants, covenants, and agrees as follows:

1. The Liens and all of the Contractor's right, title, and interest in the property described in EXHIBIT A and in the Mortgaged Property as defined in the Mortgage shall at all times be subject and subordinate in all respects to the liens and rights of the Lender under the Loan Documents, including, without limitation, liens and rights under the Mortgage, and to all renewals, replacements, consolidations, modifications, assignments, amendments and extensions thereof or thereto.
