SUBORDINATION AGREEMENT

This Subordination Agreement, made and entered into on this the 14th day of JUNE, 1994, by and between AMSOUTH BANK, N.A., as Party of the First Part, and REAL ESTATE FINANCING, INC., as Party of the Second Part.

W I T N E S S E T H

THAT, WHEREAS, JOHN H. WILSON, JR. AND MARJORIE T. WILSON, HUSBAND AND WIFE, has/have an outstanding loan in favor of AMSOUTH BANK, N.A., as set forth in INSTRUMENT #1992-28166, in the Office of the Judge of Probate of Shelby County, Alabama on certain real estate located at 1126 Country Club Circle, Birmingham, Alabama 35244 to secure an indebtedness of \$ 22,200.00 and said lien is in full force and effect; and,

WHEREAS, JOHN H. WILSON, JR. AND MARJORIE T. WILSON has/have made an application to the Party of the Second Part for a loan in the sum of \$241,400.00 and said Party of the Second Part is willing to make said loan to the said JOHN H. WILSON, JR. AND MARJORIE T. NOW, THEREFORE, in consideration of the premises and further consideration of the sum of -0-, cash in hand paid, the Party of the First Part by the Party of the Second Part, the receipt of which is hereby acknowledged, the said Party of the First Part does hereby agree that the lien of JOHN H.
