A parcel of land located in the Southeast Quarter of the Northeast Quarter of Section 29 Township 19 South Range 1 East, Shelby County, Alabama, being more particularly described as follows:

Commence at the Northeast Corner of Section 29 Township 19 South Range 1 East; thence turn an interior angle of 59 Degrees 05 Minutes 27 Seconds from the North line of said Section 29 and run Southwesterly a distance of 1913.82 feet to a point on the Southeasterly right of way line of Shelby County Highway No. 51 for the point of beginning; thence turn an angle of 07 Degrees 24 Minutes 58 Seconds to the right and run Southwesterly along said road right of way line a distance of 307.53 feet to the intersection of the Southeasterly right of way of Shelby County Highway No. 51 and the Northerly right of way line of Shelby County Highway No. 442; thence turn an angle of 110 Degrees 44 Minutes 23 Seconds to the left and run along said highway right of way line of Shelby County Highway 442 for a distance of 189.83 feet; thence turn an angle of 70 Degrees 24 Minutes 37 Seconds to the left and run 238.05 feet; thence turn an angle of 97 Degrees 48 Minutes 05 Seconds to the left and run 215.73 feet to the point of beginning.
