ASSIGNMENT OF MORTGAGE





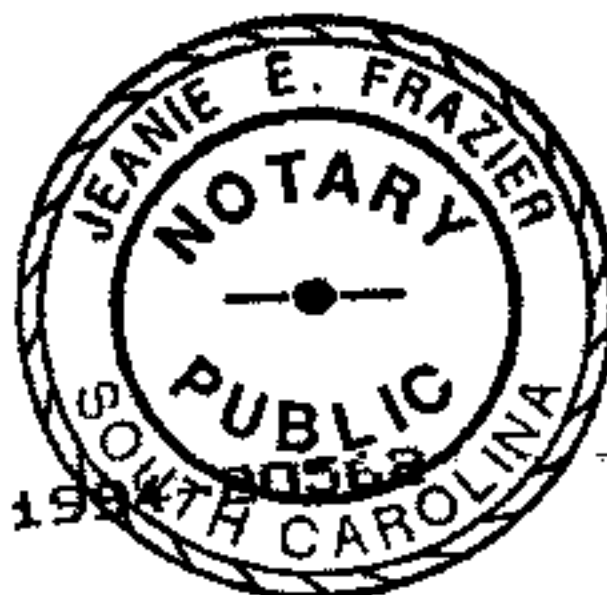
