THAT IN CONSIDERATION OF One Hundred Twenty One Thousand Dollars and 00/100 (\$121,000.00) to the undersigned Grantors in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **William Kelly King, Jr. and wife, Anne H. King**, (herein referred to as Grantors, whether one or more) do grant, bargain, sell and convey unto **Hugh B. Subject to existing easements, restrictions, set-back lines, rights of ways, limitations, if any, of record.


NOTE: \$91,000.00 of the above recited consideration was paid from the proceeds of a mortgage loan executed simultaneously herewith.
