SUBORDINATION AGREEMENT

STATE OF ALABAMA COUNTY OF <u>JEFFERSON</u>

This Subordination Agreement, made and entered into on this the <u>15th</u> day of <u>July</u>, 1994, by and between <u>ROBERT L. HAND</u>, as Party of the First Part, and <u>FIRST TENNESSEE BANK, NATIONAL ASSOCIATION</u> as Party of the Second Part.

WITNESSETH

Whereas, <u>PAULA DEAN HAND VANDIVER</u> has made an application to the Party of the Second Part for a second mortgage loan in the sum of \$ 10.300.00 and said Party of the Second Part is willing to make said loan to the said <u>PAULA DEAN HAND VANDIVER</u> provided they furnished it with a mortgage on the lands described in the aforesaid lien, and the said <u>ROBERT L. HAND</u> subordinate the above described lien and make the same second and subservient to the mortgage of <u>FIRST TENNESSEE BANK, NATIONAL ASSOCIATION</u>; and

Whereas, the said Party of the First Part is willing to subordinate its said lien and make the second and subservient to the mortgage of the said Part of the Second Part as an inducement to it to make said loan.

Now therefore, in consideration of the premises and further consideration of the sum \$ ______, cash in hand paid, the Party of the First Part by the Party of the Second Part, the receipt of which is hereby acknowledged, the said Party of the First Part does hereby agree that the lien of _______ PAULA DEAN HAND VANDIVER_____ to

ROBERT L. HAND, dated March 11, 1988 and recorded in the Probate Office of SHELBY County, Alabama, under Divorce Decree No. DR 88-81, shall be second and subservient to the mortgage of FIRST TENNESSEE BANK, NATIONAL ASSOCIATION, dated July 15, 1994 and recorded in the Probate Office of SHELBY County, Alabama, in Official Record Book 1994, Page 23 40, to secure the sum of \$10,300.00 plus interest, on the land described therein, and the said lien of the said ROBERT L. HAND shall be subordinate to the mortgage of FIRST TENNESSEE BANK, N.A.

It is further agreed that should PAULA DEAN HAND VANDIVER default in their payments under the terms of the real estate mortgage to FIRST TENNESSEE BANK, NATIONAL ASSOCIATION agrees to notify ROBERT L. HAND of said default prior to taking legal action.
