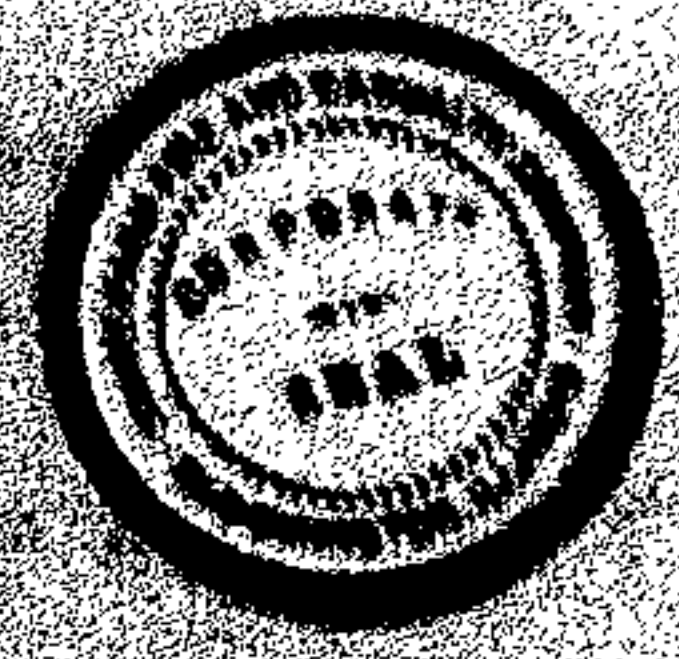

Power of Attorney

KNOW ALL MEN BY THESE PRESENTS: That STATE FARM FIRE AND CASUALTY COMPANY, an Illinois corporation, with its principal office in Bloomington, Illinois, does hereby constitute and appoint:

JACK L. WARD III

of MONTEVALLO, ALABAMA its true and lawful Attorney-in-Fact to make, execute, seal and deliver for and on its behalf as surety, any and all bonds, undertakings or other writings obligatory in the nature of a bond in Federal Administrators, executors, curator, conservator, guardian, trustee under will -- \$25,000; Receivers or Trustees in Bankruptcy -- Federal Court -- \$10,000; Plaintiff's Court Bonds -- \$2,000; Public Officials -- \$10,000; License and Permit that do not guarantee payment of taxes (compliance only) -- \$10,000. This Power of Attorney is not valid for the execution of Bid, Performance or Payment bonds.

This appointment is made under and by the authority of a resolution which was passed by the Executive Committee of the Board of Directors of State Farm Fire and Casualty Company on the 24th day of July, 1977, as is duly authorized by the By-Laws of the Company, Article II, Section 6 of the By-Laws of the Company, which resolution is:

Resolved, that the signature of the Executive Vice-President or any Vice-President and the seal of the Company may be affixed by facsimile on any power of attorney granted, and the signature of the Secretary, Vice-President or Assistant Secretary and the seal of the Company may be affixed by facsimile to any certificate of any such power and any such power or certificate bearing such facsimile signature and seal shall be valid and binding on the Company. Any such power so executed and sealed and certificate so executed and sealed shall, with respect to any bond or undertaking to which it is attached, continue to be valid and binding on the Company.

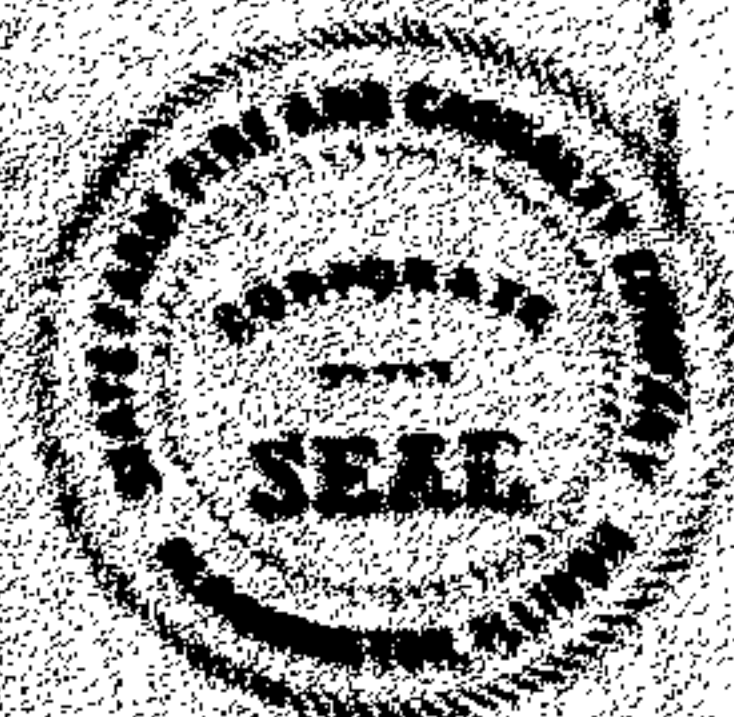
