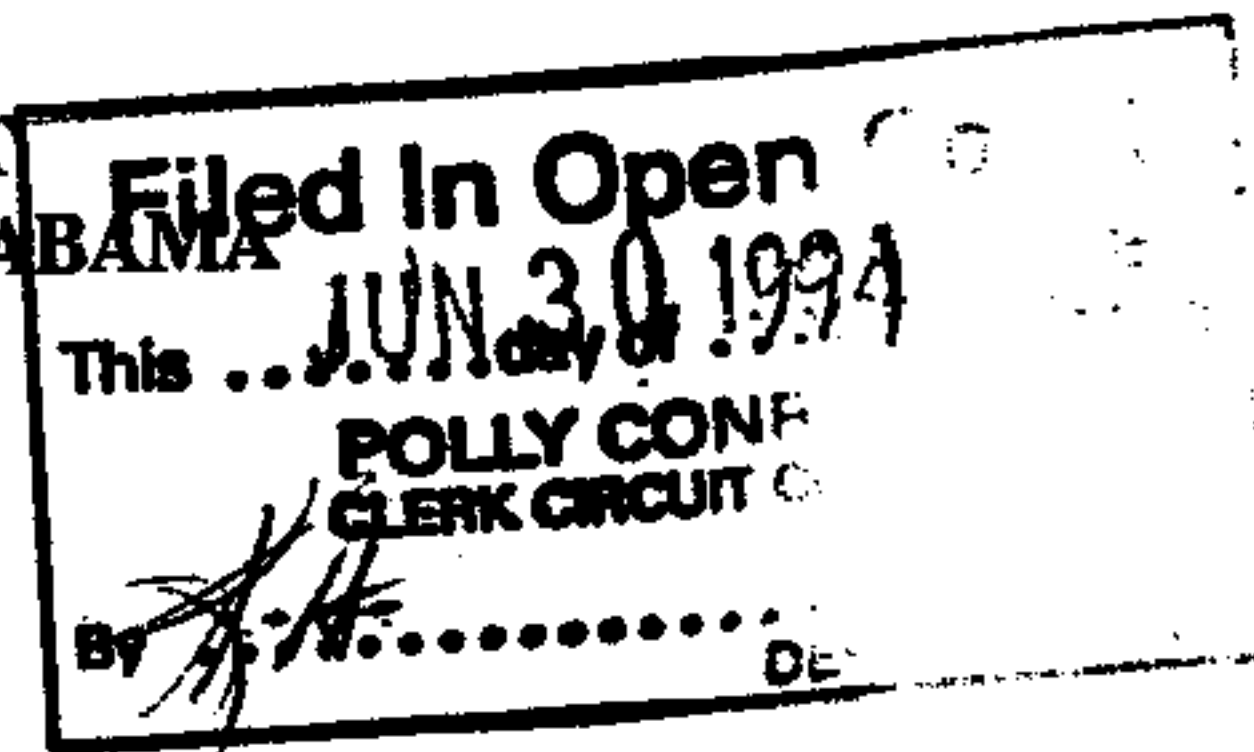

CONSENT JUDGMENT


By consent of the parties, judgment is hereby awarded in favor of plaintiffs D. Mark Clark and Charles L. Clark and against defendants Robert L. Bohorfoush ("Bohorfoush") and Boardwalk Capital & Development Corporation ("Boardwalk"), as follows:



1. Judgment is awarded in favor of plaintiff D. Mark Clark and against defendants Bohorfoush and Boardwalk, separately and severally, in the amount of \$16,250.00, plus interest at the rate of 6% per annum from November 18, 1993 through the date hereof, and thereafter at the rate permitted by law for post-judgment interest.


2. Judgment is awarded in favor of plaintiff Charles L. Clark and against defendants Bohorfoush and Boardwalk, separately and severally, in the amount of \$16,250.00, plus interest at the rate of 6% per annum from November 18, 1993 through the date hereof, and thereafter at the rate permitted by law for post-judgment interest.

3. Costs shall be taxed against the defendant Boardwalk. This is a final judgment certified as such under Ala.R.Civ.P. 54(b), and disposes of all issues in this lawsuit.


