

**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF

Pursuant to the provisions of Section 10-3A-80 of the Code of Alabama, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Corporation is St. John's Evangelical Church.

SECOND: The following amendment to the Articles of Incorporation was adopted by the members of the Corporation on April 24, 1994, in the manner prescribed by the Alabama Business Corporation Act:

BE IT RESOLVED, that the name of the Corporation be changed to **Brook Highland Community Church, Inc.**

THIRD: The number of members entitled to vote was sixty (60). The vote for the amendment was unanimous.
