That in consideration of ONE HUNDRED FORTY FIVE THOUSAND THREE HUNDRED EIGHTY FIVE & NO/10---- (\$145,385.00) DOLLARS to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, Kerry Carter and Rayburn Carter DBA Carter Construction (herein referred to as grantors), do grant, bargain, sell and convey unto Bradley C.
