IT IS THEREFORE, THE ORDER, JUDGMENT AND DECREE OF THIS COURT THAT:

1. Six Thousand, Eight Hundred Forty-Nine and 62/100 (\$6,849.62) Dollars are added to the compensatory damages of \$43,742.70 as compensatory damages in this case.

2. Additional costs are taxed against the Defendants in this case in the amount of \$3,724.10, for which if not paid, let execution issue.
