KNOW ALL MEN BY THESE PRESENTS: That in consideration of ONE HUNDRED THIRTY-NINE THOUSAND NINE HUNDRED AND NO/100 DOLLARS (\$139,900.00) to the undersigned Grantor or Grantors, in hand paid by the GRANTEEES herein, the receipt of which is hereby acknowledged, I (We), EARL I. PAYNE AND WIFE, LINDA F. PAYNE (herein referred to as GRANTOR, whether one or more) do grant, bargain, sell and convey unto, JEFFREY G. AYERS AND JERRI LYNN AYERS (herein referred to as GRANTEEES), as joint tenants, with right of survivorship, the following described real estate situated in SHELBY County, Alabama, to-wit:

And I (we) do for myself(ourselves) and for my(our) heirs, executors and administrators covenant with said GRANTEEES, their heirs and assigns, that I(we) am(are) lawfully seized in fee simple of said premises; that they are free from all encumbrances unless otherwise noted above; that I(we) have a good right to sell and convey the same as aforesaid; that I(we) will, and my(our) heirs, executors and administrators shall warrant and defend the same to the said Grantees, their heirs and assigns forever, against the lawful claims of all persons.
