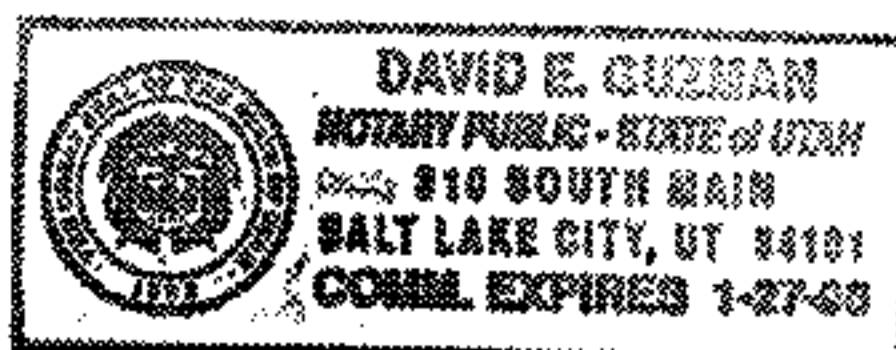


EXHIBIT "A"
