This cause came on to be heard at the time scheduled for the entry of a default judgment and upon due consideration, it is ORDERED, ADJUDGED and DECREED by the Court as follows:

ONE: Judgment is hereby rendered in favor of Plaintiff, Sam Blount Company, Inc., and against Defendant, Primrose Lane Corporation, in the amount of NINETY SEVEN THOUSAND SEVEN HUNDRED SIXTY ONE AND 09/100 DOLLARS (\$97,761.09), being NINETY THOUSAND AND NO/100 DOLLARS (\$90,000.00) on the Note plus ONE THOUSAND AND NO/100 DOLLARS (\$1,000.00) attorney's fees and SIX THOUSAND SEVEN HUNDRED SIXTY ONE AND 09\100 DOLLARS (\$6,761.09) interest from March 1, 1993, until June 2, 1994, plus interest at the legal rate thereafter until paid.
