



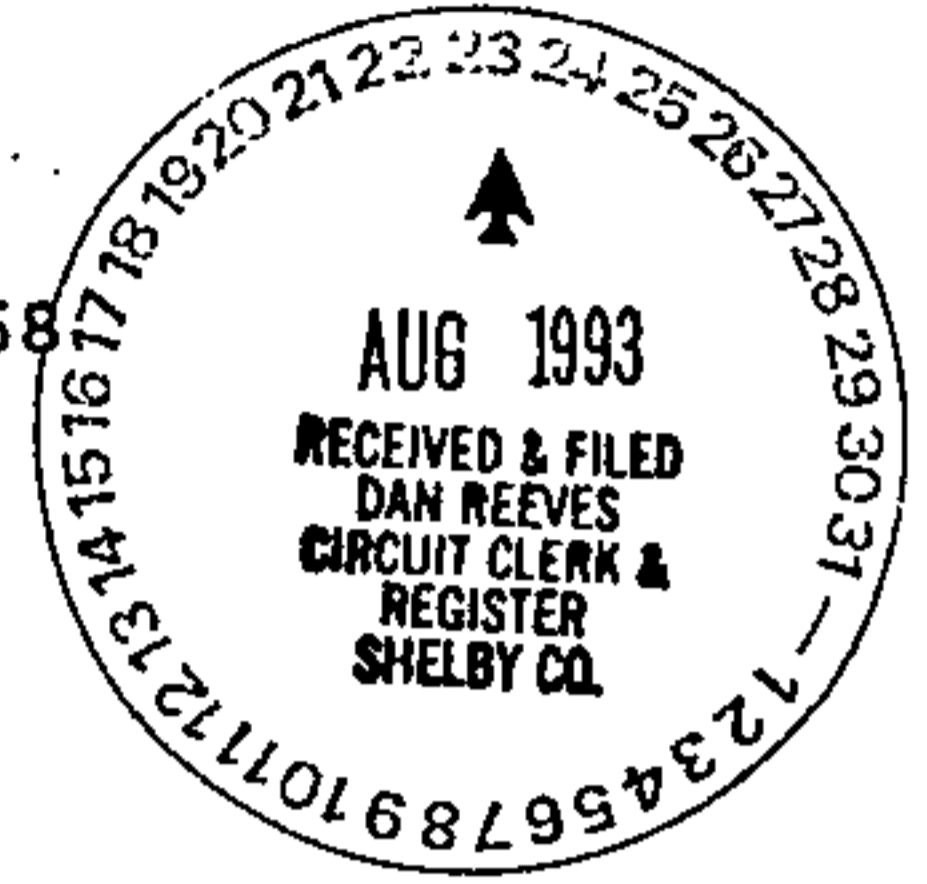

JUDGMENT

This case was called for trial on August 18, 1993, Honorable William V. Goodwyn appearing for the plaintiff, and the defendant, Carol Clark, appearing pro se. The Court heard ore tenus testimony and received documents into evidence, and upon consideration thereof **FINDS, ORDERS, ADJUDGES, and DECREES** as follows:

1. The plaintiff's claim is for professional services rendered by Mark D. McKnight, a licensed attorney, and the Court **FINDS** the issues in favor of the plaintiff.

2. The plaintiff submitted documentation of time and charges in two lawsuits which were successfully concluded by the plaintiff. The Court **FINDS** the plaintiff's charges to be reasonable for the professional services rendered and the account past due.

3. Judgment is therefore entered in favor of the plaintiff and against the defendants for the sum of \$6,097.40, plus accrued interest at six percent (6%) per annum since May 28, 1993, with costs of Court taxed against the defendants.
