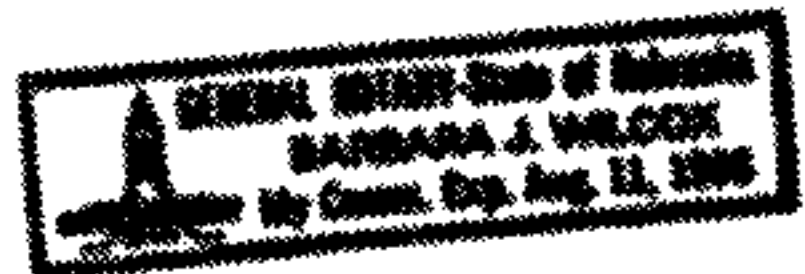


EXHIBIT A
