## CORPORATE FORM WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That in consideration of

Twenty-Eight Thousand and 00/100'S \*\*\* (\$28,000.00)

to the undersigned Grantor,

**Reamer Development Corporation**

an Alabama Corporation, (herein referred to as Grantor) does by these presents grant, bargain, sell and convey unto

**Indianwood Building Co., Inc.**

(herein referred to as Grantee, whether one or more), in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in **Shelby County, Alabama**, to-wit:

**Lot 603, according to the Survey of Eagle Point, 6th Sector, as recorded in Map Book 18, Page 33, in the Probate Office of Shelby County, Alabama.**

Subject to Ad Valorem taxes for the year 1995 and subsequent years not yet due and payable.

Subject to covenants and restrictions, building lines, easements and rights of way of record.

Subject to Mineral and Mining rights recorded in Real , Page , and all rights and privileges incident thereto.

**NOTE:** Map Book 18, Page 33 shows the following reservation: "Sink Hole Prone Area: The Subdivision shown hereon including lots and streets, lies in an area where natural lime sinks may occur. Shelby County, the Shelby County Engineer, the Shelby County Planning Commission, and the individual members thereof and all other agents, servants or employees of Shelby County, Alabama, make no representations that the lots and streets are safe or suitable for residential construction, or for any other purposes whatsoever. The subdivision is underlain by limestone and thus may be subject to lime sink activity even though there is no visible evidence of sink holes on the property."
