WARRANTY DEED

Know All Men by These Presents: That in consideration of TWO HUNDRED EIGHT THOUSAND TWO HUNDRED and 00/100 (\$208,200.00) DOLLARS to the undersigned grantor, J.E. BISHOP HOMES, INC. in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, the said GRANTOR, does by these presents, grant, bargain, sell and convey unto SARA R. WALKER, AND HUSBAND JOHN M. WALKER (herein referred to as GRANTEES, as joint tenants, with right of survivorship, whether one or more) the following described real estate, situated in SHELBY County, Alabama, to-wit:

LOT 52, ACCORDING TO THE SURVEY OF THE HIGHLANDS, FIRST SECTOR, AS RECORDED IN MAP BOOK 17 AT PAGE 100, IN THE OFFICE OF THE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA.

SUBJECT TO:

1. Subject to the taxes for the year beginning October 1, 1993 which constitutes a lien but are not due and payable until October 1, 1994.
2. Building setback line of 35 feet reserved from Piper Way as shown by plat.
3. Public utility easement as shown by recorded plat, including 10 feet in the Southerly side and irregular easement on the Northeasterly portion of lot.
4. Restrictions, covenants and conditions as set out in instrument(s) recorded in Map Book 17 page 100 and as Instrument #1993-28823 in Probate Office.
5. Title to all minerals within and underlying the premises, together with all mining rights and other rights, privileges and immunities relating thereto, including rights set out in Deed 186 page 357 in Probate Office.

And said GRANTOR does for itself, its successors and assigns, covenant with the said GRANTEES, his, her, or their heirs and assigns, that it is lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that it has a good right to sell and convey the same as aforesaid, and that it will and its successors and assigns shall warrant and defend the same to the said GRANTEES, his, her, or their heirs and assigns forever, against the lawful claims of all persons.
