AMENDMENT TO FUTURE ADVANCE MORTGAGE, ASSIGNMENT OF RENTS AND LEASES AND SECURITY AGREEMENT (ALABAMA)

THIS AMENDMENT to Future Advance Mortgage, Assignment of Rents and Leases and Security Agreement (this "Amendment") is made as of the 22nd of September , 1994, and is by and between J-WES CO., INC., an Alabama corporation (the "Borrower"), Mortgagor, and COMPASS BANK, Birmingham, Alabama (f/k/a CENTRAL BANK OF THE SOUTH), an Alabama state banking corporation (the "Bank"), Mortgagee.

PREAMBLE

Borrower entered into a Future Advance Mortgage, Assignment of Rents and Leases and Security Agreement in favor of the Bank dated July 29, 1993, recorded in the office of the Judge of Probate of Shelby County, Alabama on August 3, 1993, as Instrument No. 1993-22814 (the "Mortgage"). In order to induce the Bank to make the Loan (as defined in the Mortgage) or loans to Borrower, Borrower desires to amend the Mortgage to add the additional property described herein.

NOW, THEREFORE, in consideration of the mutual promises hereinafter contained and other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Borrower and Bank, intending to be legally bound hereby, agree as set forth below.

AMENDMENT

1. Premises. The property described on Addendum 1 attached hereto is hereby added to the Mortgaged Property (as defined in the Mortgage) in all respects and to the same extent and as fully as if the property described on Addendum 1 hereto were described on Exhibit A to the Mortgage upon its original recording. Borrower hereby grants, bargains, sells, aliens and conveys unto the Bank, its successors and assigns, the property described on Addendum 1 hereto and all estates, buildings, improvements, fixtures, furniture and personal property of every nature whatsoever now or hereafter owned by the Borrower and situated on the property

described on Addendum 1 hereto or used or intended to be used in connection with or with the operation of said property, buildings or other improvements, in all respects as if set forth in the Mortgage and to the same extent and as fully as if the property described on Addendum 1 hereto were described on Exhibit A to the Mortgage upon its original recording.

- 2. <u>No Release</u>. This Amendment is intended to add the property described on Addendum 1 hereto to the property granted and conveyed by the Mortgage. This Amendment in no way releases from the lien of the Mortgage all or any portion of the real property described therein.
- 3. Reaffirmation of Representations and Warranties. Each representation and warranty contained in the Mortgage is hereby reaffirmed as of the date hereof, and the Borrower hereby makes each representation and warranty contained in the Mortgage as to the real and personal property granted and conveyed to the Bank hereby as fully as if the real property described on Addendum 1 hereto were described on Exhibit A to the Mortgage upon its original recording.
- 4. <u>Effective Date</u>. The effective date of this Amendment is the date first set forth above.
- 5. <u>Effect of Amendment</u>. Except as specifically modified herein, all provisions of the Mortgage shall remain in full force and effect.
