loan closed simultaneously herewith.

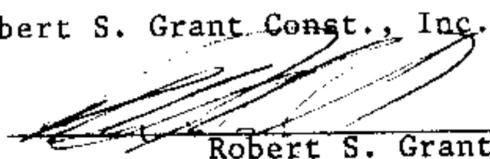

forever, against the lawful claims of all persons.

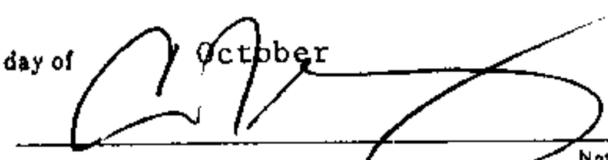
