ARTICLES OF ORGANIZATION OF MOUNTAIN VIEW QUARTER HORSES, L.L.C.

The undersigned, acting as the organizers of a limited liability company under the Alabama Limited Liability Company Act, Code of Alabama, Title 10, Chapter 12 (1975), as the same may be amended from time to time, hereby adopt the following Articles of Organization for **MOUNTAIN VIEW QUARTER HORSES**, L.L.C.
