CONFIRMATION OF INTERESTS IN TRUST

WHEREAS, Hortense Eleanor Davant under her Last Will and Testament dated October 30, 1963, which was admitted to probate in Navarro County, Texas ("the Will"), created a trust for the benefit of certain persons ("the Trust");

WHEREAS, litigation arose between persons interested in the estate of Hortense Eleanor Davant concerning the terms of the Will; and all persons interested in her estate entered a Compromise Settlement Agreement in 1980 ("the CSA") by which they agreed on the terms of the Will;

WHEREAS, the CSA restates the Will to provide that certain beneficiaries of the Trust have the power to direct the trustees of the Trust in writing as to the distribution of four-fifths of the assets of the Trust upon its termination;

WHEREAS, by a written, binding instrument dated November 19, 1986, ("the 1986 Agreement"), the beneficiaries of the Trust ("the beneficiaries"), directed NCNB Texas National Bank (successor in interest by assignment and merger to InterFirst Bank Corsicana, N.A.) as the sole, then serving trustee of the Trust ("the Trustee"), to retain the properties of the Trust in an irrevocable trust for the benefit of the beneficiaries rather than distributing the properties of the Trust to the beneficiaries upon its termination.

WHEREAS, additional persons and/or entities have acquired interests in the trust from the beneficiaries in accordance with the provisions of the CSA ("such additional beneficiaries"); and

WHEREAS, the beneficiaries, such additional beneficiaries, and the Trustee desire to clarify and confirm the beneficiaries' and such additional beneficiaries' interests in the trust and that the Trustee holds legal title to the properties of the trust, pursuant to the CSA and the 1986 Agreement, with NCNB Texas National Bank serving as sole trustee.

NOW, THEREFORE, the parties to this Confirmation of Interests in Trust hereby clarify and confirm the beneficiaries' and such additional beneficiaries' interests in the trust pursuant to the CSA and the 1986 Agreement as set out on Schedules A, B, and C, attached hereto and incorporated herein for all purposes, and confirm that NCNB Texas National Bank is serving as sole trustee, holds legal title to the properties of the trust, and continues to possess all of the trust powers pursuant to the 1986 Agreement, including, but not limited to, the power and authority to sue and be sued, and to settle, compromise, or adjust by arbitration or otherwise, any disputes or controversies in favor of or against the trust.
