That in consideration of NINETY SIX THOUSAND FIVE HUNDRED EIGHT & NO/100---- (\$96,508.00) DOLLARS to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, I, James D. Mason d/b/a Mason Construction Company (herein referred to as grantors), do grant, bargain, sell and convey unto Anita Williamson Hauth and husband, Stephen Patrick Hauth (herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:
