Bradley, Jr. and Amy B. Bradley** (herein referred to as GRANTEEES) as joint tenants, with right of survivorship, the following described real estate, situated in Jefferson County, Alabama:

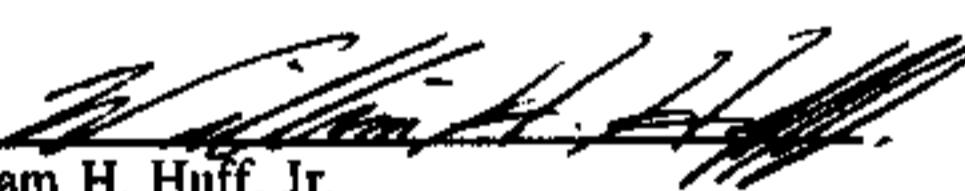

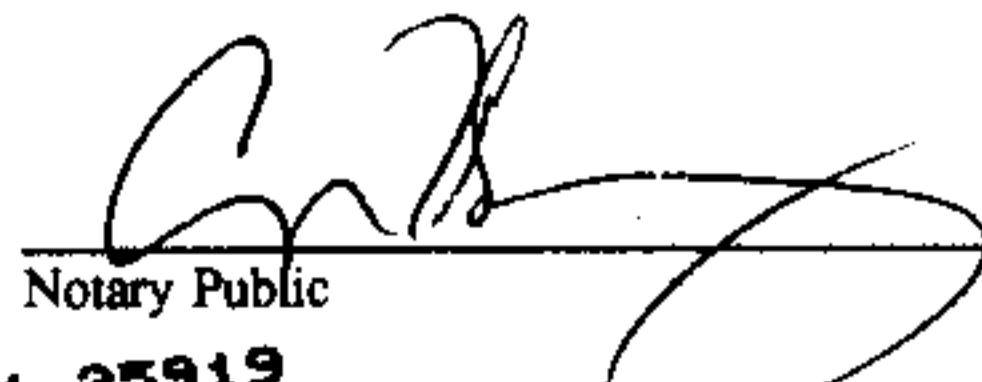
