

Councilmember Harmon Acker introduced the following Ordinance:

ORDINANCE NO. 94-345

WHEREAS, on the 3rd day of November, 1994, Southside Baptist Church (aka Monte Sil Baptist Church), Kenneth C. Hill, and Katie V. Hill filed a petition with the City Clerk of the City of Alabaster, Alabama, as required by §§ 11-42-20 and 11-42-21, Code of Alabama 1975, as amended, petitioning and requesting that the property hereinafter described be annexed to the municipality of the City of Alabaster, Alabama, which petition contained an accurate description of the property proposed to be annexed together with a map of the said property showing its relationship to the corporate limits of the City of Alabaster, Alabama, and the signatures of the owners of the property described were signed thereto;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ALABASTER, ALABAMA, AS FOLLOWS:

1. That the City of Alabaster, Alabama, does adopt this Ordinance assenting to the annexation of the following described property to the municipality of the City of Alabaster:

Begin at a point on the Alabaster City Limit line which is the intersection of the East right of way line of Alabama Highway No. 119 and the North line of the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 26, Township 21 South, Range 3 West, and run West along the North line of said $\frac{1}{4}$ - $\frac{1}{4}$ to the Northwest corner of said $\frac{1}{4}$ - $\frac{1}{4}$; then turn left and run South along the West line of said $\frac{1}{4}$ - $\frac{1}{4}$ 422.02 feet; then turn left and run East parallel with the North line of said $\frac{1}{4}$ - $\frac{1}{4}$ to the East right of way line of Highway No. 119; then turn left and run North along the East

right of way line of Highway No. 119 to the point of beginning.

2. That the corporate limits of the City of Alabaster, Alabama, be extended and rearranged so as to embrace and include such property, and such property shall become a part of the corporate area of such municipality upon the date of publication or posting of this Ordinance, as provided for in the Code of Alabama as cited above.

3. That the City Clerk be and she is hereby authorized and directed to file a copy of this Ordinance, including an accurate description of the property being annexed, together with a map of the said property showing its relationship to the corporate limits of the City of Alabaster, Alabama, to which said property is being annexed in the office of the Judge of Probate of Shelby County, Alabama.

4. That the Zoning Map of the City of Alabaster, Alabama, and any other official maps or surveys of the City shall be amended to reflect the annexation of the above-described property, and that a copy of this Ordinance be transmitted to the City Planning Commission and the Zoning Administrator.

5. That this property is temporarily zoned MR as provided in the Zoning Ordinance of the City of Alabaster, Alabama.

6. That this property is part of election Ward 7.

This ordinance was adopted and passed by the City Council of the City of Alabaster, Alabama, this the 17th day of November, 1994.
