

Councilmember Frances Glaze introduced the following Ordinance:

ORDINANCE NO. 94-346

WHEREAS, on the 3rd day of November, 1994, David Hoyt Finley, Dorothy Templin Finley, and Zora Mae Finley filed a petition with the City Clerk of the City of Alabaster, Alabama, as required by §§ 11-42-20 and 11-42-21, Code of Alabama 1975, as amended, petitioning and requesting that the property hereinafter described be annexed to the municipality of the City of Alabaster, Alabama, which petition contained an accurate description of the property proposed to be annexed together with a map of the said property showing its relationship to the corporate limits of the City of Alabaster, Alabama, and the signatures of the owners of the property described were signed thereto;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ALABASTER, ALABAMA, AS FOLLOWS:

1. That the City of Alabaster, Alabama, does adopt this Ordinance assenting to the annexation of the following described property to the municipality of the City of Alabaster:

Commence at the Northwest corner of Section 17, Township 21 South, Range 2 West, and run South 2° East a distance of 1209 feet to the point of beginning; then run North 83° 30' East a distance of 643 feet; then run South 2° 30' East to the South right of way line of Shelby County Highway No. 26 and a point on the Alabaster City Limit line; then turn right and run Westerly along the South right of way line of Highway No. 26 and the Alabaster City Limit line a distance of 241.46 feet; then turn right 93° 15' and run Northerly to the North right of way line of Highway No. 26; then continue along last course a distance of

241.64 feet; then turn left 93° 15' and run Westerly a distance of 241.0 feet; then turn left and run Southerly to the South right of way line of Shelby County Highway No. 26; then turn right and run Westerly along the South right of way line of Highway No. 26 to the West line of said Section 17; then turn right and run North along the West line of said Section 17 to the point of beginning.

2. That the corporate limits of the City of Alabaster, Alabama, be extended and rearranged so as to embrace and include such property, and such property shall become a part of the corporate area of such municipality upon the date of publication or posting of this Ordinance, as provided for in the Code of Alabama as cited above.

3. That the City Clerk be and she is hereby authorized and directed to file a copy of this Ordinance, including an accurate description of the property being annexed, together with a map of the said property showing its relationship to the corporate limits of the City of Alabaster, Alabama, to which said property is being annexed in the office of the Judge of Probate of Shelby County, Alabama.

4. That the Zoning Map of the City of Alabaster, Alabama, and any other official maps or surveys of the City shall be amended to reflect the annexation of the above-described property, and that a copy of this Ordinance be transmitted to the City Planning Commission and the Zoning Administrator.

5. That this property is temporarily zoned MR as provided in the Zoning Ordinance of the City of Alabaster, Alabama.

6. That this property is part of election Ward 6.

This ordinance was adopted and passed by the City Council of the City of Alabaster, Alabama, this the 17th day of November, 1994.

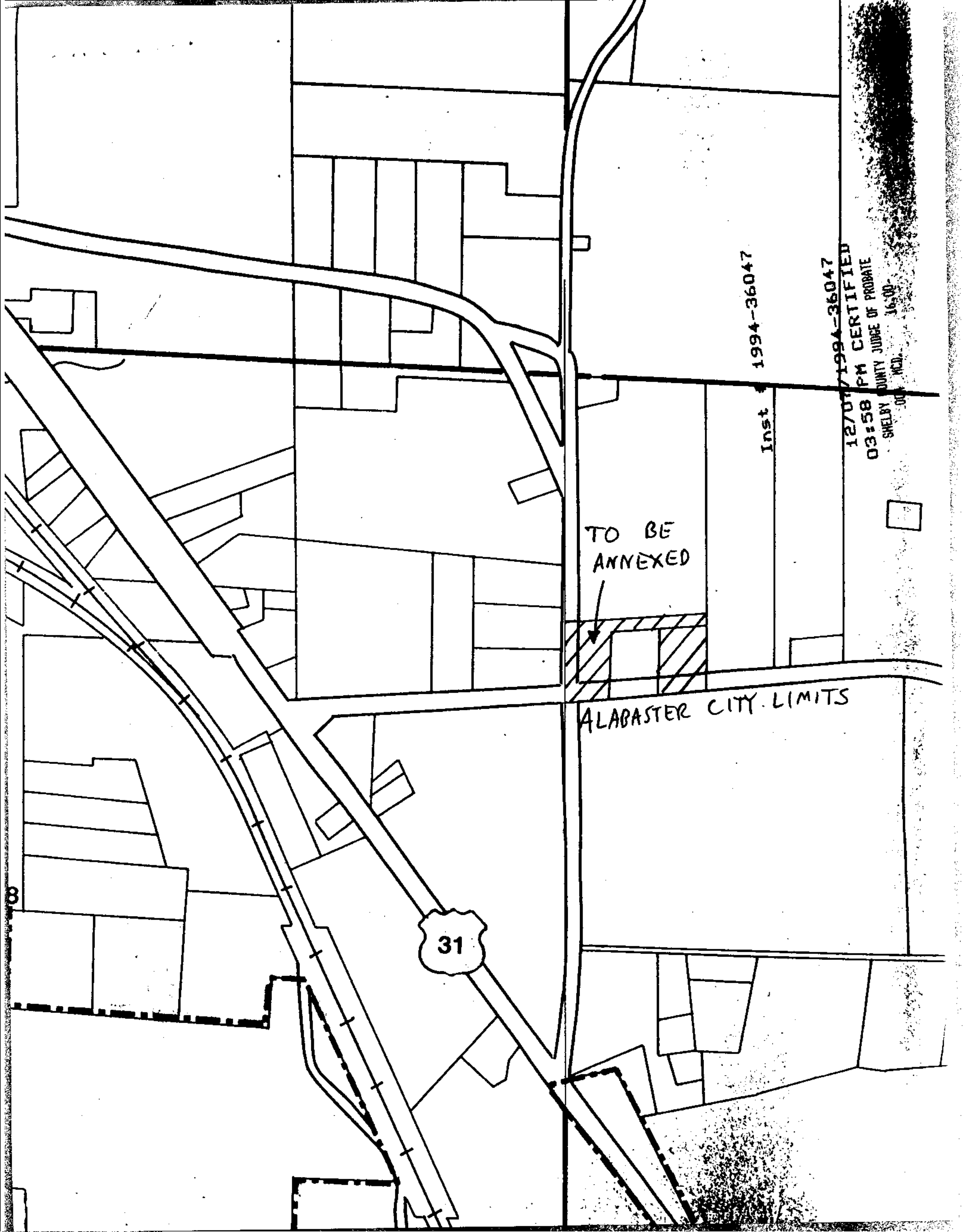
