KNOW ALL MEN BY THESE PRESENTS: That in consideration of the sum of One Dollar (\$1.00) and Other Good and Valuable Consideration to the undersigned grantor, in hand paid by the grantees herein, the receipt whereof is acknowledged, I, Sara E. Egglar, an unmarried woman, (herein referred to as the Grantor), grant, bargain, sell and convey unto Andrew B. Moore and wife, Diane M. Moore, their heirs and assigns, (herein referred to as the Grantees), an easement in and to the following described real estate, situated in Shelby County, Alabama, to-wit:

Begin at the northeast corner of the South-West quarter of the North-East quarter of Section 5, Township 20 South, Range 1 East; thence in a southerly direction along the east boundary of said quarter-quarter section 303.38 feet to the point of beginning; thence right 74 deg.36 min.56 sec. in a southwesterly direction 26.53 feet to intersection with the east right-of-way of Shelby County Highway No. 51; thence in a southeasterly direction along said east right-of-way 20.00 feet; thence in a northeasterly direction along a line parallel to the north boundary of this easement 21.03 feet, more or less, to intersection with said east boundary; thence in a northerly direction along said east boundary 20.70 feet, more or less, to the point of beginning.

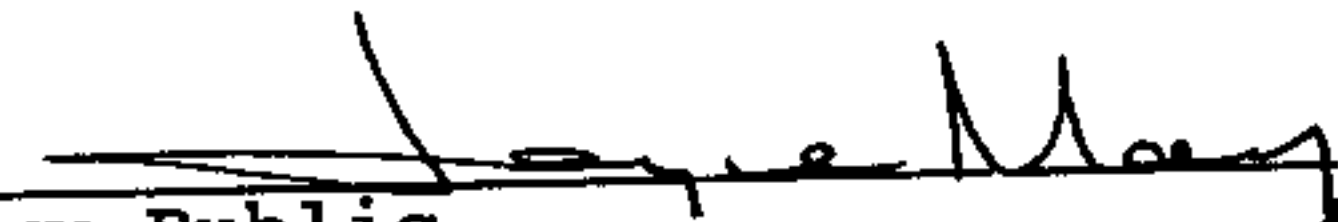
