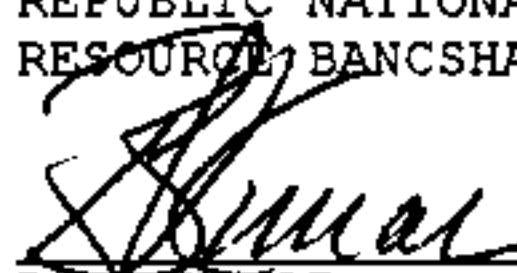

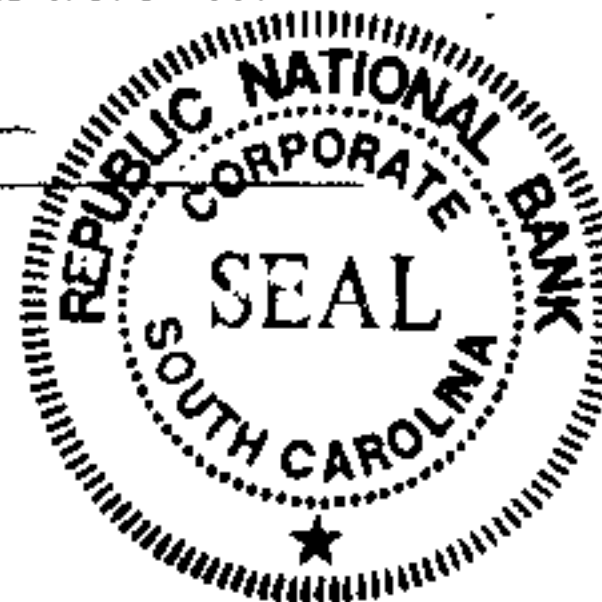
ASSIGNMENT OF MORTGAGE

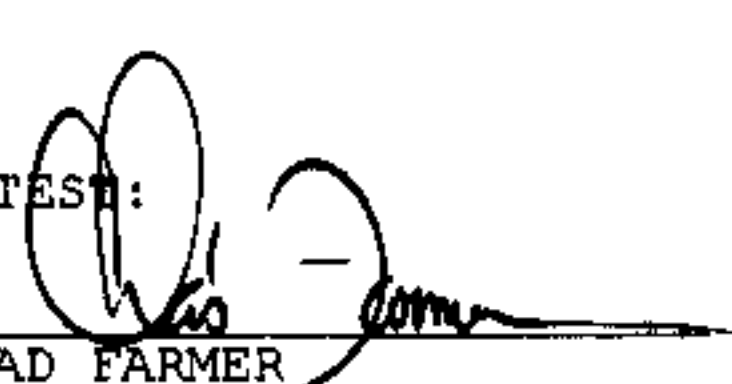

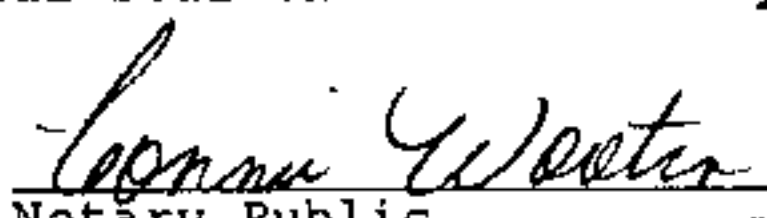

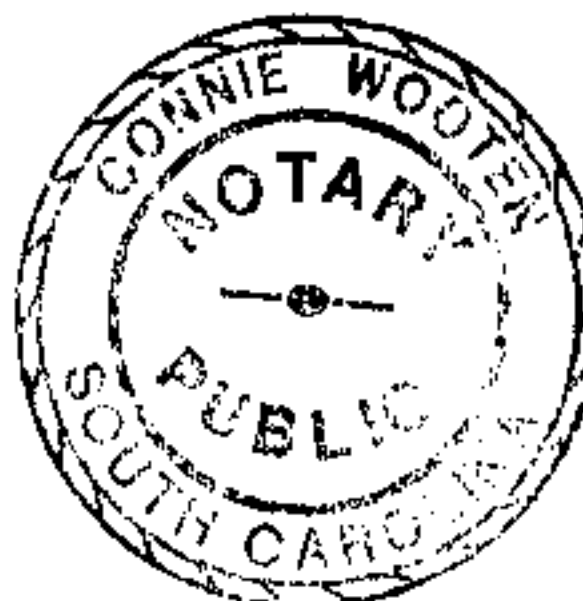
