AMENDMENT TO FUTURE ADVANCE MORTGAGE, ASSIGNMENT OF RENTS AND LEASES AND SECURITY AGREEMENT

THIS AMENDMENT TO FUTURE ADVANCE MORTGAGE, ASSIGNMENT OF RENTS AND LEASES AND SECURITY AGREEMENT is made as of the 22nd day of December, 1994, and is by and between J-WES CO., INC., an Alabama corporation (the "Mortgagor") and COMPASS BANK, a state banking corporation, successor by name change to Central Bank of the South ("Bank").

Preamble

Mortgagor entered into a Future Advance Mortgage, Assignment of Rents and Leases and Security Agreement dated as of July 29, 1993, recorded as Instrument No. 1993-22814, in the office of the Judge of Probate of Shelby County, Alabama (the "Mortgage"). Mortgagor and Bank now desire to amend the Mortgage in order to show the increase in the principal indebtedness of the Revolving Credit Commercial Note referenced therein and secured thereby from \$2,000,000.00 to \$4,100,000.00.

NOW, THEREFORE, in consideration of the mutual promises hereinafter contained and other valuable consideration, Mortgagor and Bank, intending to be legally bound hereby, agree as set forth below.

Amendment

1. <u>Amendment</u>. The first "WHEREAS" paragraph on the first page of the Mortgage is hereby amended to read as follows:

WHEREAS, J-WES CO., INC., an Alabama corporation (hereinafter called the "Borrower") is justly indebted to Bank on a revolving loan in the principal sum of up to FOUR MILLION ONE HUNDRED THOUSAND AND NO/100 DOLLARS (\$4,100,000.00) (the "Loan"), or so much as may from time to time be disbursed thereunder, as evidenced by a Revolving Credit Commercial Note dated July 29, 1993, payable to Bank with interest thereon, on demand or as otherwise provided therein, as amended pursuant to that certain Amendment to Revolving Credit Commercial Note between Borrower and Bank dated of even date herewith (the "Note"). The said \$4,100,000.00 shall be advanced by Bank to Borrower in accordance with a Master Loan Agreement for Construction Financing (the "Loan Agreement") dated July 29, 1993, the terms of which agreement are made a part of this Mortgage; and

- 2. <u>Effective Date</u>. The effective date of this Amendment is the date first set forth above.
- 3. <u>Effect of Amendment</u>. Except as specifically modified herein, all provisions of the Mortgage shall remain in full force and effect.
