

ARTICLES OF AMENDMENT

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, Frank McEwen, being President and Ralph McEwen, being Secretary of Coosa Valley Milling Company, Inc., do hereby certify that on <u>March 31, 1994</u>, the Shareholders of said Corporation did adopt an amendment to the Articles of Incorporation of the said Corporation as follows:

That Paragraph 4 of the Articles of Incorporation of said Corporation, as amended, be and the same is hereby deleted and the following Paragraph 4 is inserted in lieu thereof:

"4. The amount of the total authorized capital stock is shall be \$4,500.00 divided into 90 shares at the par value of \$50.00 each, all of which is common stock."
