I, Lewis H. King, Jr., a registered Land Surveyor in said State, hereby certify that this is a true and correct plat of a survey done by me and is more particularly described as follows;

Commence at the N.W. corner of Section 25, T-21s, R-1w which is monumented with an iron bar and run Southerly along the West boundary line of said Section 25 a distance of 2635.48 feet to the S.W. corner of the NW $\frac{1}{4}$  of said Section 25, being a rebar located in a drainage ditch; thence turn an angle of 90°59'44" to the left and run a distance of 3232.20 feet to an iron pin and the point of beginning; thence turn an angle of 0°01'38" to the left and run a distance of 405.92 feet to a point; thence turn an angle of 56°38'23" to the left and run a distance of 285.68 feet to an iron pin on the bank of a lake; thence continue along the same line for a distance of 15.0 feet to a point in said lake; thence turn an angle of 83°53'49" to the left and run a distance of 170.49 feet to a point in said lake; thence turn an angle of 12°12'22" to the left and run a distance of 170.49 feet to a point in said lake; thence turn an angle of 83°53'49" to the left and run a distance of 15.0 feet to an iron pin on the bank of said lake; thence continue along the same line a distance of 508.90 feet to the point of beginning. Said parcel of land is lying in the SW $\frac{1}{4}$  of NE $\frac{1}{4}$ , Section 25, T-21s, R-1w and contains 3.28 acres.

EASEMENT FOR ROADWAY

Commence at the N.W. corner of Section 25, T-21s, R-1w which is monumented with an iron bar and run Southerly along the West boundary line of said Section 25 a distance of 2635.48 feet to the S.W. corner of the NW $\frac{1}{4}$  of said Section 25, being a rebar located in a drainage ditch; thence turn an angle of 90°59'44" to the left and run a distance of 3232.20 feet to a point marked with an iron pin; thence turn an angle of 56°40'01" to the left and run a distance of 211.74 feet to the point of beginning; thence turn an angle of 93°07'50" to the left and run a distance of 205.30 feet to a point; thence run along a curve to the right (concave Easterly and having a radius of 130.93 feet and a central angle of 84°04'10") for an arc distance of 192.11 feet to a point; thence run along the tangent of said curve a distance of 176.87 feet to a point; thence turn an angle of 8°47'45" to the left and run a distance of 259.30 feet to a point; thence run along a curve to the right (concave Southeasterly and having a radius of 220.0 feet and a central angle of 52°25'42") for an arc distance of 201.31 feet; thence run along the tangent of said curve a distance of 151.73 feet to a point; thence turn an angle of 59°38'24" to the left and run a distance of 94.54 feet to a point; thence turn an angle of 7°00'00" to the right and run a distance of 362.42 feet to a point on the Southern right-of-way of County Highway No. 28; thence turn an angle of 98°28'22" to the right and run a distance of 40.52 feet to a point on said Southern right-of-way line; thence turn an angle of 81°31'38" to the right and run a distance of 354.69 feet to a point; thence turn an angle of 7°00'00" to the left and run a distance of 114.31 feet to a point; thence turn an angle of 59°38'24" to the right and run a distance of 174.65 feet to a point; thence run along a curve to the left (concave Southeasterly and having a radius of 180.0 feet and a central angle of 52°25'42") for an arc distance of 164.71 feet to a point; thence run along the tangent of said curve a distance of 262.37 feet to a point; thence turn an angle of 8°47'45" to the right and run a distance of 179.94 feet to a point; thence run along a curve to the left (concave Easterly and having a radius of 90.93 feet and a central angle of 84°04'10") for an arc distance of 133.42 feet to a point; thence run along the tangent of said curve a distance of 207.49 feet to a point; thence turn an angle of 93°07'50" to the right and run a distance of 40.06 feet to the point of beginning. Said right-of-way being a strip of land 40 feet wide as herein described and is lying in the SW $\frac{1}{4}$  of NE $\frac{1}{4}$ , and NW $\frac{1}{4}$  of NE $\frac{1}{4}$ , Section 25, T-21s, R-1w.
