

ARTICLES OF INCORPORATION

OF

The undersigned, acting as Incorporators of a corporation under the Alabama Business Corporation Act of 1995 (Title 10-2B) and the Alabama Professional Corporation Act (Title 10-4-380), adopts the following Articles of Incorporation for such corporation:

1. NAME and ADDRESS: The name and address of the corporation is:

2. PERIOD OF DURATION: The period of duration is perpetual.

3. PURPOSES: The purpose or purposes for which the corporation is organized is the transaction of any and all lawful business for which corporations may be organized under the Alabama Business Corporation Act with an emphasis on the practice of accounting.

In furtherance, but not in limitation of the aforesaid purposes of this corporation and without limitation of the powers conferred by statute or general rules of law, this corporation shall have the following powers in addition to others now and hereafter conferred by:

To apply for, purchase, or acquire by assignment, transfer or otherwise, and hold, mortgage or otherwise pledge, and to sell exchange, transfer, deal in, and in any manner dispose of, and to exercise, carry out and put to use any license, power, authority, concession, franchise, letters patent formulae, know-how, methods, copyrights, trademarks, tradenames, or any other right or privilege, and to grant licenses or right in any of the foregoing and to make or grant any of the foregoing which any corporation can make or grant.

4. AUTHORIZED SHARES: The aggregate number of shares which the corporation shall have authority to issue shall be 1,000, said shares to have the par value of \$1.00 per share.




