

**ORDINANCE NO. 258-1**

**AN ORDINANCE AMENDING THE LEGAL DESCRIPTION OF  
ORDINANCE NO. 258, ANNEXATION OF OLDHAM PROPERTY**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PELHAM, ALABAMA AS  
FOLLOWS:**

**SECTION 1.** The legal description for the Oldham Annexation shall read:

A parcel of land situated in the NE 1/4 of the NW 1/4 of Section 29, Township 20 South, Range 2 West in Shelby County, Alabama and being more particularly described as follows:

Commence at the SE Corner of the NE 1/4 Of the NW 1/4 of Section 29, Township 20 South, Range 2 West; thence N 0deg-49'-08" E along the east line of said 1/4-1/4 section a distance of 613.85' to the **POINT OF BEGINNING**; thence continue along the last described course and the east line of said 1/4-1/4 section a distance of 330.00'; thence N 89deg-10'-52" W a distance of 462.00'; thence S 0deg-49'-08" W a distance of 330.00'; thence S 89deg-10'-52" E a distance of 462.00' to the Point of Beginning. Said parcel contains 3.50 acres, more or less.

**SECTION 2.** This ordinance shall become effective immediately upon its adoption and publication as required by law.
