**CERTIFICATE OF INCORPORATION  
OF  
CHRIST COMMUNITY CHURCH**

To the Honorable Thomas A. Snowden, Jr., Judge of Probate of Shelby County, Alabama:

The members of Christ Community Church, being a church or religious society and desiring to become incorporated pursuant to Alabama Code § 10-4-20 *et seq.*, and having adopted a resolution on December 18, 1994 signifying their intention to become incorporated, and having elected three Initial Trustees, hereby file this their Certificate of Incorporation:

The Elders from time to time in office within Christ Community Church shall serve as the Trustees of the Church, with their terms of office as Trustees to be co-extensive with their terms of office as Elders. In the event that no Elder is serving as such at any time, the Deacons of Christ Community Church shall serve as Trustees until the appointment of Elders. In the event that no Deacon or Elder is serving as such at any time, the membership shall elect a minimum of three Trustees from among the membership by majority vote at any regular or special meeting of the members.

There currently being no Elders or Deacons of Christ Community Church, the following members have been elected as Trustees of the Church: Robert G. Foster, Gerald W. Kelly, and David J. Guin (the "Initial Trustees"). The Initial Trustees of the Church shall serve for a term of one year from their election and thereafter until their successors are appointed, but their term in office shall expire upon the appointment of Elders or Deacons or upon their ceasing to be members of the congregation for any reason.

The corporate name selected is Christ Community Church.

The organization of this corporation and the election of trustees was held at Pelham, Alabama on the eighteenth day of December, 1994.


