This Amendment (the "Amendment") is made and entered into on ember 30th , 19 94 , by and between David R. Spruiell and wife, Phyllis R. Spruiell December 30th

(hereinafter called the "Mortgagor", whether one or more) and First Commercial Bank (hereinafter called the "Mortgagee").

RECITALS

- David R. Spruiell and wife, Phyllis R. Spruiell (hereinafter called the "Borrower", whether one or more) has (have) entered into an Agreement entitled First Commercial Bank "Home Equity Line of Credit Agreement", executed by the Borrower in favor of the Mortgagee dated November 28th , 1988 (the "Credit Agreement"). The Credit Agreement provides for an open-end line of credit pursuant to which the Borrower may borrow and repay, and reborrow and repay, amounts from the Mortgagee up to a maximum principal amount at any one time outstanding not exceeding the sum of **Fifteen Thousand and no/100*** ********), (the "Credit Limit").
- B. - 1. The term "Credit Limit" as used in the Mortgage shall mean the Amended Credit Limit of **Forty-five Thousand and no/100********** **************************** Dollars (\$ **45,000.00**
- 2. In addition to the other indebtedness described in the Mortgage, the Mortgage shall secure the payment of all advances heretofore or from time to time hereafter made by the Mortgagee to the -Borrower under the Credit Agreement, or any extension or renewal thereof, up to a maximum principal amount at any one time outstanding not exceeding the Amended Credit Limit of **Forty-five Thousand and no/100*
