DURABLE POWER OF ATTORNEY

COUNTY OF SHELBY

KNOW ALL MEN BY THESE PRESENTS, That I, JOHNNIE GIVHAN LEMLEY, a legal resident of Shelby County, Alabama, hereby constitute and appoint TWANTRIDA L. STACY as my true and lawful attorney, for me and on my behalf to lease, mortgage, or convey by warranty deed any real estate owned by me or in which I vest any interest; to sign and endorse checks, drafts, bonds, stocks or bills of exchange; to sue and defend in my name whenever the same may become necessary; to place and effect insurance on any property owned by me, or in which I vest any interest; and to give receipts for me whenever the same be required.

I do further authorize said attorney for me, and for my account to deposit in any bank or banks deemed satisfactory, all monies coming into said attorney's hands and all checks, bonds, bills of exchange, promissory notes or drafts, and other securities or monies payable to me, and for that purpose to sign and endorse the same for deposit or collection, and from time to time to withdraw all or any of said funds on deposit and for that purpose to draw checks in my name.

I further authorize said attorney for me, and on my behalf, to borrow money, give notes, mortgages, or other security agreements on our behalf; to sell any property, real or personal, owned by me or in which I have any interests, and to use these proceeds therefrom on my behalf as said attorney deems proper and satisfactory; to consent to all medical treatment deemed necessary and in my best interests, hereby giving and granting said attorney full power and authority to do and perform every act and thing necessary to be done in the premises as I might or could do if personally present, with full power of substitution and revocation, hereby ratifying all that my said attorney may do pursuant to this power.

THIS POWER OF ATTORNEY SHALL NOT BE AFFECTED BY THE DISABILITY, INCOMPETENCY OR INCAPACITY OF THE PRINCIPAL HEREIN AND SHALL BE VALID UNTIL REVOKED IN WRITING.
