- With respect to a Mortgage or Deed of Trust, the foreclosure, the taking of a deed in 3. lieu of foreclosure, or the completion of judicial or non-judicial foreclosure or termination, cancellation or rescission of any such foreclosure, including, without limitation, any and all of the following acts:
 - The substitution of trustee(s) serving under a Deed of Trust, in accordance with a. state law and the Deed of Trust;
 - Statements of breach or non-performance; b.
