AFFIDAVIT

BEFORE ME, the undersigned authority, personally appeared, **REV. LORENZA MITCHELL**, who, after first being duly sworn, states as follows:

My name is Lorenza Mitchell. I am familiar with the family history of Maggie Dotson. I live in the community and have known the family for many years. I make this affidavit based on my own personal knowledge for the purposes of assisting in clearing the title to property described as:

A part of Lot 26 according to Thomas' Addition to the Map of the Town of Aldrich, as recorded in Map Book 3, Page 52, of the Shelby County, Alabama, being further described as follows: Begin at the intersection of the West line of Peach Street (Central Avenue) and the South line of Main Street in the town of Aldrich; thence run South, along Peach Street, 67.5 feet; thence turn an angle of 89 degrees 25 minutes to the right and run West a distance of 110.0 feet; thence turn an angle of 114 degrees to the right and run Northeasterly, a distance of 120.0 feet to a point on the South line of Main Street; thence turn an angle of 100 degrees 20 minutes to the right and run Southeasterly a distance of 74.7 feet, more or less, to the point of beginning.

Maggie Dotson died July 30, 1977. At the time of her death, Maggie Dotson was not married, her husband having predeceased her in 1932. Maggie Dotson left surviving her nine children; namely, Mattie Dotson Smith, Lucile Dotson Small, Annie Joe Dotson Coleman, Ruth Dotson Morton, Emma Dotson Robinson, Warren Dotson, Alice Dotson Burt, Sadie Dotson Allen, and William Dotson. Maggie Dotson also had one daughter, Mary Dotson Glover, who predeceased her, having died in 1945. Maggie Dotson had two children who only lived a few weeks after birth and died in infancy.

Of Maggie Dotson's children, only five are now living. They are Mattie Dotson Smith, Lucille Dotson Small, Annie Jo Dotson Coleman, Ruth Dotson Morton and Emma Dotson Robinson. Alice Dotson Burt, Sadie Dotson Allen and William Dotson, died since Maggie Dotson's death. Alice Dotson Burt died in 1985 and did not leave surviving her any spouse or children; William Dotson died in 1989 and did not leave surviving him any children or a spouse; Sadie Dotson Allen died in 1992 and did not leave any spouse or children surviving her. Warren Dotson, a son of Maggie Dotson, died in 1986 and left surviving him three children, his wife having predeceased him. Warren Dotson left surviving him William Dotson, Wayne Dotson and Wanda Dotson, all of whom are over the age of nineteen years and are of sound mind. Mary Dotson Glover, a daughter of Maggie Dotson, predeceased Maggie Dotson, having died in 1945. Mary Dotson Glover left surviving her two children, namely Ronald Glover and Felecia Glover Harris. Both of these children are over nineteen and of sound mind.
