That in consideration of ONE DOLLAR (\$1.00) and other good and valuable consideration to the undersigned grantor, in hand paid by the GRANTEE herein, the receipt whereof is acknowledged, I, Sylvester David Finley, an unmarried man, (herein referred to as grantor), do grant, bargain, sell and convey unto my son, Ervin Lee Finley, (herein referred to as GRANTEE), the following described real estate situated in Shelby County, Alabama to-wit:

An undivided one acre interest in the following parcels:

The NW 1/4 of the NW 1/4 of Section 22, the East half of the SW 1/4 of the NW 1/4 of Section 22, and the NW 1/4 of the SE 1/4 of Section 15, all in Township 18 South, Range 1 East; and in the SW 1/4 of the SE 1/4 and the SE 1/4 of the SW 1/4 of Section 15, and the East half of the East half of the SE 1/4 of Section 16, all in Township 18 South, Range 1 East, Shelby County, Alabama.

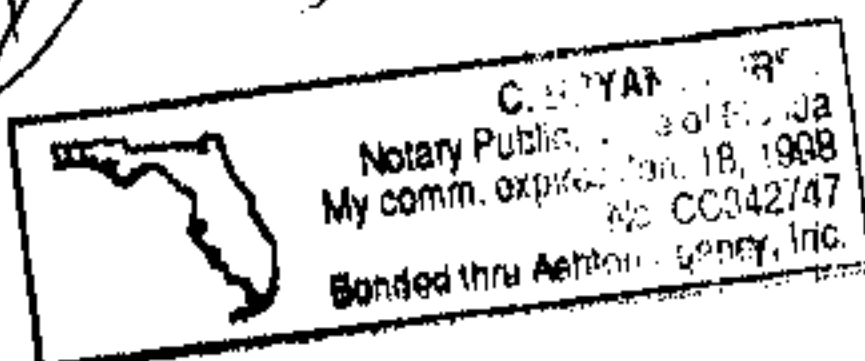
TO HAVE AND TO HOLD to the said grantee, his heirs and assigns forever.

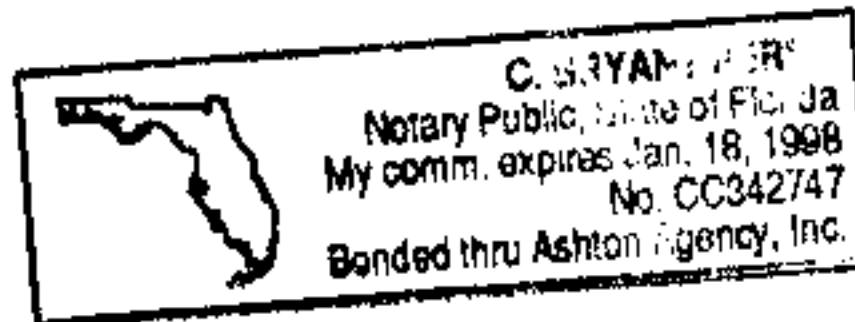
