**ORDER**

On or about November 17, 1994, the plaintiff in this civil action filed a Motion for Summary Judgment, which was heard by the Court on January 9, 1995. The Court, having considered the motion, the Affidavit of Keith A. Woods attached thereto, and the Narrative Summary of Material Facts in Support of Plaintiff's Motion for Summary Judgment, is of the opinion that such motion is due to be granted. Accordingly, it is hereby ORDERED that the plaintiff's Motion for Summary Judgment is granted.


The Court specifically finds, as follows:

1. The amount due and owing from defendant to plaintiff, as of the date of this judgment, is Fifty Thousand Nine Hundred Dollars and Thirty-Eight Cents (\$50,900.38).
2. Plaintiff is due an award of attorney's fees under the contract that is the subject of this action. The Court finds a reasonable attorney's fee to be Ten Thousand Dollars (\$10,000.00).
3. Costs are to be taxed against the defendant.

The Court specifically determines that there is no just reason for delay and directs that this Order shall constitute a final judgment in accordance with Rule 54(b) of the Alabama

Rules of Civil Procedure. The Court directs that the Clerk of the Court enter judgment in favor of plaintiff and against defendant in the amount of Sixty Thousand Nine Hundred Dollars and Thirty-Eight Cents (\$60,900.38), plus court costs.
